

Sales Agreement

SmartCity PLC (the "Vendor") offers for sale, land for residential located at Osun Government Reserved Area (Oranmiyan New Town), Off Gbongan-Ibadan Road, Osun State, herein referred to as "the Estate.

1. PROPERTY DESCRIPTION

HazanaEstate is situated at the Osun Government Reservation Area, Gbongan Road, Osun, as part of the New Town Development initiative by the Osun State Government; in the neighbourhood of other choice in the area with notable infrastructure. Major landmarks are: Osun State House of Assembly, the Central Bank Osogbo, NTA, Department of Petroleum Resources, Zone 11 Police Command.

2. CHEQUE PAYMENTS

Payment by cheques shall only be acknowledged when payments are received in cleared funds by the Vendor. Acknowledgement of payments shall be by email, which shall be deemed delivered within three hours of sending email.

3. DOCUMENTATION

Documentation for a sale shall comprise of the following:

6. TRANSFER OF INTEREST

- (a). Where payment has been completed, transfer of interest in Unit or subscription by a Purchaser shall only be done upon receipt of prior express consent of the Vendor.

7. SERVICE CHARGE
