Question: Where is VISION CITY Located?

Question: What is Development levy?

Answer: It is the cost paid for the placement of Infrastructure within the estate.

Question: Are there any hidden charges?

Question: Is there any time limit to commence work on my land after allocation?

Answer: No there is no time limit to commence work but after the Building Plan approval has been sought and received from the appropriate authorities. However, maintainers of undeveloped plots must be done frequently for the safety of the residents living in the estate.

Question: Can I resell my plot(s) or property?

Answer: YES, but the company has to be duly informed for documentation processes.

Question: Can I pay cash to your agent?
